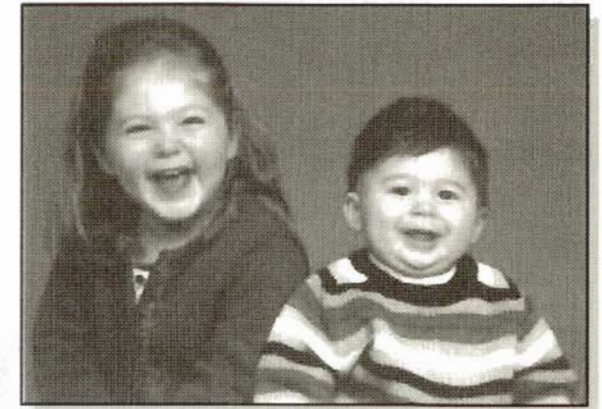

SEPTA Access:

SEPTA buses stopping between 16th & 19th and Market are as follows: 17,31,32,33,38,48,124,125 and the "C" bus.

SEPTA trolleys stopping between 16th & 19th on Market Street: 10,11,13,33,34,36 and 48.

The Broad Street line and the El train stop at 15th & Market Streets, four blocks east on Market Street.

We are also one block south and two blocks west of Suburban Station, for all Regional Rail trains.

From I-95 North: Travel 95 South to 676 West, exit at 15th Street, proceed South on 15th Street to JFK Boulevard, turn right on JFK Boulevard, travel four blocks to 19th Street, turn left on 19th Street and proceed one block to Market Street, cross Market Street and the parking lot is the first driveway located to your left on 19th Street.

From 76 West: Travel 76 East to 676 East, exit 23rd Street, proceed straight by following Winter Street to Logan Circle and make a right turn onto 19th Street. Travel four blocks (cross over Market Street) and the parking lot is the first driveway located to your left on 19th Street.

From 95 South: Travel 95 North to 76 West exit, follow George C. Platt Bridge to traffic light, take a left and proceed on 76 East to 30th Street Station exit, proceed straight to Market Street, turn right onto Market Street; proceed ten blocks to 19th Street, turn right onto 19th Street and the parking lot is the first driveway located to your left on 19th Street.
